Data Controller would like to notify the Data Subjects of

- the ways how the Data Subjects may exercise their rights (right to access, right to erasure, right to restriction, right to objection and right to transferability). In such cases Data Subjects may send their declaration to lazarlovaspark@lazarlovaspark.hu or any other contact of Data Controller to exercise their rights. Further more, should their rights be infringed, Data Subjects may turn to the authorities (please find their contact details at www.naih.hu) or to a court of law competent in their area of residence, and may claim a penalty. Data Controller would like inform Data Subjects, that their exercising of their rights may have certain conditions or restrictions related to certain instances of data protection, these conditions are to be examined by Data Controller when Data Subjects exercise their rights. Should there be an case when Data Subject cannot exercise their rights in relation to their data being processed, then Data Controller is to inform Data Subject in writing (including electronic forms of writing) of the legal reason excluding/restricting the exercise of rights. Data Controller is to keep a record of such cases
- more detailed information on the individual instances of data procession is available in Annex I of the Internal Data Protection Regulations.
- No profile generation occurs in any phase of data procession.
- Data transfer to a third party may occur in the course of data procession, this is described in the detailed information of the data procession. Should any type of data described below data be transferred in the course of data procession, then the addressee of the transfer(data controller or data processor) is displayed in Annex II.
